

"Sell & Win with United"  
Contest Terms and Conditions

The "Sell & Win with United" contest (the "**Contest**") is brought to you by United Airlines, Inc. ("United").

1. **Term:** The Contest is valid from 12:01a.m EST October 14, 2019 and closes November 26, 2019 at 11:59p.m EST (the "Contest Period").

2. **Eligibility:** The Contest is open to all Travel Companies in the United States and Canada and their subagents (each an "Account") who are (i) ARC or IATA approved in good standing with United; and (ii) hold a valid ARC or IATA Travel Industry I.D. card.
